23rd Meeting

At the 23rd meeting of the Council of Representatives we welcomed three new Representatives attending for the first time; from the Spanish Critical Care Nursing Association (Maria Carrion Torre); the Icelandic Association of Critical Care Nurses (Guðrún Jónsdóttir);

and the new Finnish Representative (Catharina Alanko). There were 16 Representatives present from Austria, Belgium, Cyprus, Denmark, ESPNIC, Finland, Germany, Greece, Iceland, Italy, Netherlands, Norway, Slovenia, Sweden, Switzerland and the UK.

Elections

There were two positions for election to the Board of Officers: the Secretary and the Vice President. Heike Strunk (Germany), the current Secretary was re-elected for

another term of office and Bronagh Blackwood (UK), the acting VP was elected as Vice President.

Update on Research Projects

Ongoing funded EfCCNa projects

1. The 'Nurses' Autonomy' study is a questionnaire survey of participating nurses at the 2008 Congress exploring autonomy, moral distress and empowerment. The data collected at the last Congress are currently being analysed.

2. The E-Link Study (European survey of Levels of Intensive-care Nurses' Knowledge) is a web-based

questionnaire survey to determine knowledge of European critical care nurses to help inform the education strategy. It has been translated into 15 national languages & data collection has begun.

3. The Delphi study is a web-based study using a Delphi research technique to identify intensive care nursing research priorities

within Europe to help inform the research strategy. It is now entering Phase 3 and a final report is expected at the next Council Meeting in the autumn.

3rd EfCCNa & 27th ANIARTI Congress, Florence 2008

This was a magnificent success and was the largest critical care nursing event in Europe. There were 2022 delegates (1555 from Italy; 459 from 23 European countries; 8 from Australia; 2 from USA & 1 from India). The Congress profit was €125,000, making a profit to EfCCNa of €35,000. The success of the Congress was mainly attributed to the ANIARTI conference team (the Italian Critical Care Nurses' Association organise the Congresses themselves without the aid of an external project management team) and the huge attendance support normally provided by Italian critical care nurses to their association's annual Congresses

Clear Signal of the German Parliament: Living Will Documents are legally binding

On June 17, 2009, after six years of debate the German Parliament finally issued a fundament for a legally binding of the patients will. The new law sets a legal precedent for the use of living will's and specifies that the treating physician must follow the directives as stated in the patient's living will. This also applies in that case that where treatments and other actions might lead to the death of the individual.

The World Federation of Critical Care Nurses (WFCCN)

In September 2004 in Cambridge UK, EfCCNa and the WFCCN had their first joint meeting. At the meeting there were several ideas to produce projects jointly, where it is preferable to speak with one voice. Other thoughts are chairing objectives, key projects, and exchange of good practice and position statements. It is the view of the representatives at the meeting, that it is important the wheel should not be re-invented. Since then there have been several other meetings where one or two representatives on behalf of EfCCNa have met with the council of WFCCN.

The only joint project EfCCNa and WFCCN have had so far is the online journal CONNECT – the world of critical care nursing.

On August 28 – September 1st, 2009 there is a joint congress and in collaboration with the WFSICCM, SIAARTI, ANIARTI and the WFCCN.

Prior to the congress there will be a WFCCN council meeting. Rosa Thorsteinsdottir and John Albaran will be representing EfCCNa at this meeting. One of the main issues that will be discussed is the future and organisation of WFCCN.

EfCCNa celebration ...

In October 2009, EfCCNa will celebrate its tenth anniversary. The celebration will take place in Berlin on October 2-4, where the Federation was officially established. Heike Strunk who is the secretary of EfCCNa and the German representative has been very busy for months planning the celebration programme and the council meeting that will also take place that weekend.

The EfCCNa adventure started already in October 1997. With sponsorship from Siemens Europe, representatives of over twenty European critical care nursing associations met in Rotterdam for a weekend, to discuss the possibility of setting up a federation of critical care nurses. At this first meeting, the broad aims and objectives of a European Federation were established. At two further meetings, in Stockholm and Zagreb, we further developed and refined the purpose of the Federation, and established its founding principles of equity and collaboration.

Ultimately, on October 2nd 1999 in Berlin the European federation of Critical Care Nursing associations was officially established. At that time, it had a working Constitution and it elected an administrative board. So when Heike Strunk suggested to hold the celebration in Berlin in October 2009, there was no doubt that it would be the right thing to do. There will be a two days council meeting during Saturday and Sunday as usual.

In addition there will be a celebration programme which will include a reception held by the German association (DGF) on Friday night. A festive dinner on Saturday night and on Monday the council members have an opportunity to participate in a Berlin day, where we will be given the opportunity to do a boat trip to sightsee beautiful Berlin. Several guests have been invited and there will be issued a press release as well.

When looking back at our short history, the work that has already been accomplished by the council members and the member associations has already proved its validation and the commitment of the members to continue the good work. For the next 10 years I have no doubt that EfCCNa will have even a stronger voice, that by then all critical care nurses who are members of our member associations will know who EfCCNa is, what it stands for and be proud of our achievements.

Congratulations to all EfCCNa members and let's continue proving that by working together – we achieve more.



EfCCNa Fellows

In October 2008, those representatives that have made a lasting contribution to the growth, establishment and profile of the Federation were awarded EfCCNa Fellowships.

Wouter de Graaf: was the Dutch representative since 2001; treasurer since 2002 – 2005; First president of EfCCNa 2005-2008. Wouter is a leader; he is innovative, supporting, encouraging and capability to development and improvement. He is an enabler and a facilitator. His major goal was to “push” EfCCNa forward. To reach

that goal, he recognized that EfCCNa had to have a president and a board of officers. In 2005 the council elected the first president and board of officers. For the past years he has also been EfCCNa representative and treasurer in the European Specialist Nursing Organization, ESNO.
